# NIA EXPLORES OPPORTUNITIES THROUGH CHALLENGES

"Problems can become opportunities when the right people come together." - Robert South

NIA celebrates its 55 years of serving the Filipino farmers through faithfully fulfilling its mandate of developing water resources into effective and efficient irrigation systems nationwide.

In 1974, Mr. Amnon Golan of World Bank recognized NIA as "the finest irrigation agency in the whole of Asia". However, NIA has never been exempted to challenges. Among them were regimes that the Agency endured dearth in irrigation investment that curtailed irrigation development and a prospect for non-viability, inevitable effects of climate change, and the election promise of President Rodrigo Roa Duterte that came to life when he signed the Free Irrigation Service Act (RA 10969) on February 2, 2018.

Not to impede NIA's mandate, all endeavors have been explored to keep the Agency responsive alongside the mission to improve the farmers' quality of life. Based on the inventory as of December 31, 2017, the estimated total irrigable area in the country is 3,128,631 hectares, out of which 60.35% or 1,887,986.49 hectares have been developed with 1,240,644.51 hectares remaining area to be developed.

The climate change adaptation works of the Agency include bio-engineering slope protection (Coconet) being implemented in National and Communal Irrigation Systems nationwide. Likewise, the Pasa Small Reservoir Impounding Project (Pasa SRIP) funded through a grant from the Korea International Cooperation Agency (KOICA) is implemented with the purpose of reducing the adverse impact of climate change through the construction of water impounding facilities.

With the able leadership of the men on the helm, NIA delved into other waterbased income by inviting private entities to venture on solar and hydropower projects utilizing irrigation facilities nationwide, as well as exploring the linkage with other local government units the feasibility of agro-tourism destination. These have been conceptualized but now it leaped from the drawing board and slowly coming to life. Revenues from traditional sources of income have been augmented through government's subsidy.

Solutions are sought to innovate even in very limited resources. Trainings are funded through savings from traditional celebration of anniversaries and other special events, such as Christmas programs, preferring a more subdued celebrations. Indeed, investment for human resources is one of the priorities.

Unity worked for Team NIA. The Agency became ISO 9001: 2008 certified in July 2017. To date, as we expand our vision, NIA gears for ISO 9001:2015 certification. Thanks to the men and women whose unparalleled commitment made NIA, even at age 55, resilient like a mythical phoenix rising above challenges and soaring to endless opportunities.

## 2<sup>ND</sup> NIA MANAGERS' CONFERENCE

NIA started and will continue to conduct Managers' Conference to cover important aspects and plans for a more efficient and transparent agency.

# MAXIMIZING THE UTILIZATION OF IRRIGATION WATER THROUGH HYDRO AND FLOATING SOLAR POWER PROJECTS

While the National Irrigation Administration (NIA) continues to hold firm in its mission of constructing, operating, and maintaining irrigation systems, it does not stop venturing into some productive means of maximizing the utilization of irrigation water.

This year, NIA had been inviting interested parties to invest in hydroelectric power project in the 379 identified potential sites nationwide. Incidentally, four are already operational – the 8.5 MW MARIS Main (South) Canal Hydroelectric Power in Isabela, Rizal Hydropower Plant in Nueva Ecija, Bulanao Mini-Hydropower Plant in Kalinga, and Marbel #1 MHPP in Southern Cotabato.

Recently, NIA also opened its dams and reservoirs for floating solar power project as the SN Aboitiz Power Group has proposed a water-based solar power project in Magat Dam in Isabela which features solar panels fixed to floats on the water surface. It will conduct a 2,500-square meter pilot project over the Magat reservoir, a small-scale preliminary study prior to the performance of the large-scale project. The floating solar power project's actual size is yet to be decided after the study.

As NIA had its research regarding this project, it was found out that water-based solar power project is more beneficial than the land-based one because the latter converts large portion of agricultural lands into solar plants. Doing so makes irrigable farmlands smaller. This results to the decrease in food production which poses a threat to the country's food security. It also defeats NIA's purpose of constructing and developing more irrigation systems in the country to ensure rice sufficiency. Instead of indulging into land-based solar project, NIA thus offers its dams and reservoirs for the water-based project which can achieve the same purpose of increasing power production while saving agricultural lands.

Looking on how much energy this water-based project can produce, Administrator Ricardo R. Visaya said that one hectare of solar field can produce one megawatt (MW). For instance, in Magat Dam with a reservoir of 4,500 hectares, if 200 hectares will be utilized for water-based solar power, 200 MW will be generated and 200 hectares of agricultural lands will be saved.

This project can also be beneficial by providing additional income to the government, prevent the decrease of the water level in the dams and reservoirs due to evaporation, and provide sanctuary for marine life as it prevents fishes and other species from dying due to hot temperature. Interestingly, this could also be a tourism promotion for NIA's dams and reservoirs. The solar power plant will be picturesque to the visitors' eyes as it will be an array of panels affixed to a flotation mechanism above the water surface.

NIA would never regret entering into this project. Magat Dam is just the first NIA irrigation facility to be installed with this. There are still many big dams and reservoirs to be utilized for this purpose, such as the Pantabangan Dam and Casecnan Dam in Nueva Ecija.

Both hydro and floating solar power projects of the Agency are non-irrigation related projects which would add to the further development of irrigation systems in the country.

# QMS 9001:2015 MANAGEMENT REVIEW OF THE NIA

Management Review or Readiness Assessment is the 10<sup>th</sup> task of the Agency in its preparations for the Technical Guidance on Transition and Expansion of the Certified Quality Management System (QMS) to ISO 9001:2015. This activity took place last May 29, 2018 at the DCIEC Convention Hall.

In attendance to this activity were the Central Office Department Managers, Internal Quality Audit Members of NIA Central Office, UPRIIS, Region IV-A and Quezon IMO, NIA Top Management Officials, and ISO Mentors from the Development Academy of the Philippines (DAP). There were six major chunks of information that were presented and deliberated:

- 1. Background Information on NIA QMS,
- 2. Updates on the Status of QMS Implementation where the works of the different teams were shared (Risk Management Team, Documented Information Team, Quality Workplace Team, Training and Education Team, and the Knowledge Management Team),
- 3. Results of the IQA conducted by the IQA Teams to the different C.O. organizations, as well as to the other field offices covered for the ISO. Of the 327 Audit Criteria, 268 or 82% were conformities and 48 or 15% were OFIs (Opportunities for Improvement and 11 or 3% as Non-Conformities),
- 4. Performance of different Agency processes like Management Processes, Core Processes, Support Processes and ISO Core Team Processes, as well as the Agency's Service Conformity which is basically reflected in our 2017 Performance Scorecard with a total score of 92.67%,

- 5. Areas for Improvement which include the submission of the Agency's organizational strengthening and exploring other sources of income as a GOCC such as hydropower, bulk water supply, and solar power; trainings of personnel as well as automation of processes, and
- 6. Actions from previous Management Review.

NIA Top Management participated actively in providing their valuable inputs on risk and opportunity assessment being undertaken by the Agency and the conduct of an ISO hour by each department. On their part, the Mentors from DAP gave their observations on the Management Review. Most notable are the general observations, which are, Management Teams to:

- review the effectiveness of the Quality Management System and
- review effectiveness of its actions taken to address the risks and opportunities.

The Management Review enabled the Top Management to appraise the QMS and ensure its continuing suitability, adequacy, effectiveness, and alignment with the strategic direction of the Agency.

## NIA: PAINTING THE PHILIPPINE MAP GREEN

A side from keeping the country's agricultural lands green through irrigation, the National Irrigation Administration (NIA) also contributes in keeping the mountains' forestlands green as well through the National Tree Planting Activity held every NIA Anniversary Week, which is actually done simultaneously in all regions of the country. This serves as the kick-off activity for the celebration of its Founding Anniversary. This year, when NIA turns 55 years old, a total of 48,638 seedlings were planted by thousands of NIA officials, staff, and friends to the different locations in the archipelago.

Selected species are a combination of fruit trees, forest trees (endemic species) and industrial tree species. These are commonly planted in watershed areas of an irrigational system.

The selected participants from the Central Office joined the Region 3 Tree Planting Activity held at Porac-Gumain River Irrigation System in Barangay Nabuclod, Floridablanca, Pampanga. The site is the resettlement area of the Aetas. It is also the watershed area of the proposed Upper Gumain Dam.

The activity started at around 9:00 am with heavy and occasional rain showers. Green raincoats were distributed together with trowels, white towels, blue long sleeve shirts, and salacots. The wet weather did not stop NIAns in letting the seedlings rest in the slippery and muddy slopes of that mountainous area. The rainwater did not become a hindrance to that tree planting activity. It rather served as a natural irrigation system for the newly planted seedlings.

All seedlings assigned for the Central Office and Region 3 were already planted as early as 10:00 am. Indeed, an activity done by several hands can be carried out easily, fast, and efficiently. An activity done for a noble purpose is always accomplished successfully. May all those seedlings grow fully and become sturdy trees in the years to come giving lots of benefits to our country's ecosystem.

The National Tree Planting is NIA's way of greening the Philippines as it has always aimed to paint the Philippine map green by bringing irrigation water to the farmlands in the entire country.

## P4.37-BILLION CHIGO RIVER PIP BREAKS GROUND

The 4.37 billion-peso Chico River Pump Irrigation Project (CRPIP), the first NIA flagship infrastructure project under President Rodrigo Duterte's Build, Build, Build Program, broke ground on June 8, 2018. NIA Administrator Ricardo R. Visaya and Mr. Jin Yuan, the Economic and Commercial Councellor, Embassy of the Republic of China, together with Acting Regional Irrigation Manager Constancio G. Bana-ay, Jr., Acting Project Manager Roland V. Apaga, Cagayan Governor Manuel N. Mamba, Kalinga Governor Jocel C. Baac, Congressman Allan Jesse Mangaoang of the Lone Ditrict of Kalinga, and Pinococ Barangay Captain Saturnino B. Tamdog, led the ceremonial groundbreaking in Sitio Karaw, Pinococ, Pinukpuk, Kalinga.

The project components include the construction of Pump House in Katabbogan, Pinukpuk, Kalinga, appurtenant structures, installation of six units of electric motor-driven pumps with an individual capacity of 3,000 liters per second, 30 kilometers of transmission line, construction of two conveyance tunnels, 4.403 kilometers of main diverion canal, 33.596 kilometers of main canal, 100.48 kilometers of lateral canal, roads, irrigation and drainage facilities, eight kilometers of access road, and 84.387 kilometers of service roads, as well as the construction of Project Management Office in Naruangan, Tuao, Cagayan and institutional development. CRPIP will be constructed by China CAMC Engineering Co. Ltd.

Once completed, the water delivery will be efficient and substancial to irrigate 8,700 hectares of riceland in 22 barangays of Cagayan and Kalinga, benefitting 4,350 farmers and their families. It is also projected to create 14,784 temporary jobs during project implementation and 8,700 permanent jobs when the project becomes completely operational in three years' time. Furthermore, CRPIP targets to contribute 36,217 metric tons of milled rice to the country's rice consumption, to incur \$15.57M savings from rice importation, and to yield an incremental income of P75,193/hectare/year inclusive of high value crops.

"This project is our best gift to tomorrow's China-Philippines Friendship Day", said Councellor Yuan in his message. As June 09, 2018 serves as the 43rd commemoration of the Filipino-Chinese Diplomatic Relations which was initiated in 1975, he also commended NIA for doing very efficient work in the program preparation. The ceremony was well attended by almost 2,500 farmers, more than a thousand local, national, and international dignitaries.

Governor Mamba expressed his gratefulness to President Duterte for his hometown is a recipient of

such a big project. He also encouraged his constituents to support the project because it has been a culmination of their lifelong dream.

Governor Baac, who shared that work was suspended in Kalinga PLGU to celebrate and attend the occasion, requested NIA to add more farm lands to be irrigated in Kalinga, in addition to the 1,150 hectares already included in the design plans. He appealed that if possible, since the water source is Kalinga, the benefitted area be increased to at least half of Cagayan's total service area.

Administrator Visaya said that the appeal will be one of the serious priorities that NIA will be looking into before the submission of 2019 Budget Proposal.

CRPIP is the first Chinese soft-loan funded infrastructure project in the Philippines. The scheme of development is through pumps where the water is lifted from the source, without the construction of any type of dam. Contrary to the belief of some concerned people, no areas will be submerged.

# TRANSITION / 1<sup>st</sup> Surveillance Audit by A Third Party Towards ISO 9001:2015

As early as January this year, the Agency has been preoccupied with the preparations for the QMS Certification Audit by the 3<sup>rd</sup> Party Certifying Body, AJA Registrars Inc. The effort is geared towards the award of an ISO 9001:2015 Certificate. Several Teams were created within the Agency to carry out the requirements for the process. The activity was called a *Transition Audit* as NIA is moving from ISO 9001:2008 to ISO 9001:2015.

The ISO QMS Team of the NIA has been rallying towards ISO 9001:2015 because the ISO 9001:2008 will expire by September 23, 2018. Normally, there is a transitional period of three years after the publication of each new version of ISO 9001. This period provides the organizations a period to adapt their quality management to match the latest version. Organizations must therefore implement the new ISO 9001:2015 standard before September 23, 2018 in order to continue complying with ISO 9001.

ISO 9001 is the world's most popular and most commonly used standard for quality management systems.

According to Luc Marivoet<sup>1</sup>, a "standard is not a law, but an agreement or best practice that an organization can apply voluntarily and which reflects a good level of professionalism". A Quality Management System (QMS) is an instrument with which an organization can determine how it can meet the requirements of its customers and the other relevant interested parties that are involved in its activities.

An ISO 9001 Quality Management System: (sourced from handouts of ISO trainings)

- shows that you provide products and services of consistent quality;
- shows that you provide products and services that meet the customer's requirements, comply with the law and legislation, and meet the organization's own requirements;
- can help you streamline your business processes and continuously improve them;
- helps you increase customer satisfaction;
- is positive for your image: you show that you comply with internationally recognised quality standards. This is often a requirement for customers and suppliers to do business with you.

The first three clauses in ISO 9001:2015 are largely the same as those in ISO 9001:2008, but there are considerable differences between ISO 9001:2008 and ISO 9001:2015 from the fourth clause onwards. The last seven clauses are now arranged according to the PDCA cycle (Plan, Do, Check, Act). Clauses 4, 5, 6, and 7 of ISO 9001:2015 come under PLAN, Clause 8 comes under DO, Clause 9 comes under CHECK, and Clause 10 is covered by ACT.

ISO 9001:2008 and ISO 9001:2015 also use different terminologies as is reflected in the succeeding table.

ISO 9001 is managed by the International Organization for Standardization (ISO) in Geneva, Switzerland. ISO is an independent membership organization and the world's largest developer of voluntary international standards. However, ISO does not provide certification or conformity assessment which is performed by accredited certification bodies like AJA Registrars Incorporated.

A new version of ISO 9001 appears about every seven years. The most recent ISO 9001:2015 standard is constructed around seven quality management principles:

- 1. customer focus,
- 2. leadership,
- 3. engagement of people,
- 4. process approach,
- 5. improvement,
- 6. evidence-based decision making, and
- 7. relationship management.

The most awaited day was June 26-27, 2018, when the 3<sup>rd</sup> party audit team AJA Registrars Inc., composed of Mr. Melvin Grueso (TL), Ms. Merian Domingo, Mr. Nicanor Altares, and Ms. Thea Santiago came to NIA for the Audit proceedings. The first body to be audited was the NIA Top Management who were a paramount example of team work as each answered confidently the questions thrown by the Auditors. The show of support was very evident. The remaining hours of the day was spent on the audit of each office. After all the offices were audited, the Audit Team held a private audit process meeting. A closing meeting was held early in the evening where the audit findings from the other areas (UPRIIS Head Office, Region 4A, and Quezon IMO) and that of the Central Office were shared to the NIA Top Management and Department Managers. The result gave the NIAns a great relief and fulfillment for a job well done as there were only eight Opportunities for Improvement (OFIs) and one minor Non Conformity (NC). The NC which was shared by all audited offices was that of Clause 7.5 of ISO 9001:2015, "All documented information must go under proper review and approval procedures to ensure it is fit for its intended purpose."

Another basis for the NC was Clause 9.3 "Management review - At least once a year, the top -level management must review the QMS in order to determine its:

- Appropriateness Does it serve its purpose and satisfy the needs of the organization?
- Adequacy Does the QMS conform to standard requirements?
- Applicability Are activities performed according to procedures?
- Effectiveness Does it accomplish the planned results?

The review must evaluate possibilities for improvement and needs for changing the QMS, Quality Policy, and objectives. Considering the inputs for the management review, such as the results of the previous management reviews, changes in the context, customer satisfaction survey results, performance of the QMS and suppliers, etc., the top management must make decisions regarding opportunities for improvement, need for changes in the QMS, and resources needed for the upcoming period."

NIA committed to address/comply with the NC in 10 days' time instead of the 30 days given as deadline by AJA.

The construction of much awaited efficient irrigation system is underway in Sorsogon Province as the Ibingan Small Reservoir Irrigation Project (SRIP) of the National Irrigation Administration (NIA) in the Municipality of Prieto Diaz had its Groundbreaking Ceremony on June 25, 2018.

NIA Administrator Ricardo R. Visaya, together with Senator Francis "Chiz" Escudero who contributed a lot in making this project approved, led the breaking of the ground and laying of the capsule for the 27.20-meter high dam with a storage capacity of 0.6592 MCM. Now on its fifth year, the Rice Achievers Awards (RAA), an annual DA-wide event, recognizes the efforts of outstanding rice producers in the Philippines. The program is one of DA's ways of motivating and showing appreciation for institutions, groups, and individuals for their contributions in its food self-sufficiency thrust. It aims to recognize the country's top rice producers for their steadfast efforts to the inclusive growth of rice farming industry.

The RAA is given to outstanding provinces, cities/ municipalities, Irrigators Associations (IAs), and Small Water Irrigation System Associations (SWISAs). In partnership with the Department of Agriculture (DA) Agricultural Training Institute (ATI), the National Irrigation Administration (NIA) Technical Working Group (TWG) led the evaluation of all IAs from NIA and SWISAs.
