600 BOHOLANO FARMERS TO BENEFIT FROM P645-MILLION BENLIW SRIP



With the goal of promoting agro-tourism within its irrigation systems nationwide, the National Irrigation Administration (NIA) has recently completed the P645-million Benliw Small Reservoir Irrigation Project (Benliw SRIP), a medium-scale irrigation development project located in the 2nd Congressional District, Municipality of Ubay, Bohol. On May 27, 2021, the inauguration of the project was presided by Senior Deputy Administrator Abraham B. Bagasin.

NIA Top Management Officials, headed by Administrator Ricardo R. Visaya, see the great potential of Benliw SRIP as an agro-tourism destination site with its scenic and breath-taking view. The project includes the construction of a 21-meter-high zoned earthfill dam with a length of 517 meters, a reservoir with a catchment area of 5.60 square kilometres that can store 2.86 million cubic meters (mcm) of water, irrigation and drainage canals, and other appurtenant structures.

With water source from Pasanan Creek, the project is expected to provide timely and reliable irrigation water supply to 400 hectares of agricultural land in barangays of Benliw, Emelda, Cagting, and Sinandigan, benefitting

600 farmers and their families. Aside from irrigation, the project is also expected to provide other incidental benefits, such as flood control, watershed management, aqua-culture as a supplementary food source to the residents in the area, and soil conservation since it prevents the soil from eroding or reducing fertility caused by over-usage.

The Agency remains committed to its mandate of providing efficient, reliable, and sustainable irrigation service to the Filipino farmers, the agricultural heroes who feed the nation.



The project implementation of Benliw SRIP became successful through the collective effort and strong partnership among NIA, Local Government Units (LGUs), and Irrigators Associations (IAs).

NIA TURNS OVER P631-MILLION BARBAR EARTHFILL DAM IN ILOCOS SUR

The National Irrigation Administration (NIA) turned over the P631-million Barbar Small Reservoir Irrigation Project (Barbar SRIP) to the seven Irrigators Associations (IAs) of San Juan and Magsingal, Ilocos Sur on May 6, 2021. The inauguration and turnover ceremony was held at the project site located in Barangay Barbar, San Juan, Ilocos Sur.

Amidst the current pandemic, NIA Administrator Ricardo R. Visaya led the turnover of the Barbar Earthfill Dam with a storage capacity of 0.861 million cubic meters designed to irrigate a total of 846-hectare agricultural land covering 11 barangays of Barbar, Camangaan, Nagsupotan, Nagsabaran, Muraya, Immayos Sur, Guimod Sur, and Bacsil in the Town of San Juan, and the barangays of Macatcatud, Caraisan and Barbarit in the neighboring town of Magsingal, Ilocos Sur. A total of 1,156 farmers farmers and their families from the said barangays will benefit from the completed Barbar SRIP.

Irrigation facilities of the Barbar SRIP consists of a fivekilometer main canal and a total of 16.28 kilometers of lateral canal. Access roads were constructed simultaneous with the lateral canals having the same length as the latter, providing mobility and accessibility for farmers and their farms inputs and products.

Aside from increase in agricultural production through additional areas of around 319 hectares and yield increase up to 5.2 metric tons, the project also helps in mitigating flood by impounding typhoon waters for use as irrigation. Moreover, it strengthens watershed recharging the aquifer in the area that will re-establish the vegetation and helps enhance the biodiversity.

Present in the event were Ilocos Sur Governor Ryan Luis V. Singson, Ilocos Sur 1st District Representative Deogracias Victor Savellano, 1st District Board Member Efren Rafanan, San Juan Mayor Elaine Sarmiento, and NIA Region I Manager Angelito S. Miguel and Ilocos Sur Irrigation Management Office (IMO) Division Manager Gertrudes A. Viado who will facilitate the operation of the dam.

Dispersal of the 10,000 Tilapia fingerlings was also done in addition to the 50,000 fingerlings earlier poured at the dam waters from the Bureau of Fisheries and Aquatic Resources (BFAR). This reinforces its livelihood component for the farmer-beneficiaries of the irrigation project. Right after the ceremony, the newly elected officers of the Federation of Irrigators Association of Barbar SRIP took their oath and sworn to before the NIA Administrator himself.

Furthermore, Governor Ryan Singson highlighted in his message his deep gratitude to Administrator Visaya and to the whole Agency for initiating such a timely project which he described as the most daring among the irrigation projects in the entire country he has ever seen.

NIA Top Management Officials, headed by Administrator Ricardo R. Visaya, assure that the Agency remains committed to its mandate of providing efficient, reliable, and sustainable irrigation service to the Filipino farmers.

NIA FINISHES P878-MILLION UPPER TABUATING DAM IN NUEVA ECIJA



Despite the prevalence of the COVID-19 pandemic, the National Irrigation Administration (NIA) finished the P878-million Upper Tabuating Small Reservoir Irrigation Project (Upper Tabuating SRIP) situated in Barangay Nazareth, General Tinio, Nueva Ecija.

Completed in December 2020, Upper Tabuating SRIP involves the construction of Earthfill Dam with a height above the lowest streambed of 25.56 meters and length of 760 meters, with a storage capacity of 4.96 million cubic meters. The dam was able to irrigate the entirety of its target service area prior to its inauguration.

The project is expected to provide irrigation water to around 700.87 hectares of agricultural land which will benefit about 223 farm families distributed among the barangays of Nazareth, Rio Chico, Bago, and San Mariano in the Municipalities of General Tinio and

Peñaranda in Nueva Ecija.

Presided by Administrator Ricardo R. Visaya, Upper Tabuating SRIP held its inauguration on May 25, 2021. The implementation of the project was carried out by NIA-Upper Pampanga River Integrated Irrigation Systems (NIA-UPRIIS) Division III, now headed by Acting Division Manager Elenita L. Toquero, under the leadership of UPRIIS Department Manager Rosalinda B. Bote.

Present during the inauguration were General Tinio Municipal Mayor Isidro T. Pajarillaga, Nueva Ecija Provincial Governor Aurelio M. Umali represented by Provincial Human Resource Management Office Chief Roseten E. Tugaff, Nueva Ecija 4th District Representative Maricel N. Nagaño, NIA Deputy Administrator for Administrative and Finance Sector Romeo G. Gan, NIA UPRIIS Department Manager Rosalinda B. Bote, UPRIIS Acting UPRIIS Division III Manager Elenita L. Toquero, other NIA officials, and local farmers.

Capping the event was the dispersal of 12,000 Tilapia fingerlings into the dam water to help strengthen the irrigation project's livelihood component for the farmer-beneficiaries.

Administrator Ricardo R. Visaya assures that the Agency remains committed to its mandate of developing and maintaining irrigation systems in support of the agricultural program of the government.

NIA INAUGURATES SICALAO DIVERSION DAM

Another project under the helm of National Irrigation Administration (NIA) Administrator Ricardo R. Visaya held its Ceremonial Inauguration on May 10, 2021 in Lasam, Cagayan. The inaugurated undertaking is the Sicalao Diversion Dam of the P30.332-million Zinundungan River Irrigation System (Zinundungan RIS) located in Barangay Sicalao of the said municipality. NIA Senior Deputy Administrator Abraham B. Bagasin attended and presided the event.

Zinundungan RIS, whose water source is the Sicalao River, comprises gravity/ogee-type diversion works with an ogee length of 52.4 meters and a height of 2.60 meters. One unit of sluice gate which measures 3 meters x 2 meters has a discharge capacity of 2.050 cubic meters per second. The system's service area is 2,938.78 hectares and operations area of 2,127.53 hectares. The project aims to provide sustainable

agricultural development in the municipality by optimizing the irrigation potential of the system. The project will provide reliable irrigation water supply to 23 barangays, benefiting 1,639 farmers of Lasam.

NIA, NHA SUPPORTS IP HOUSING PROJECT IN ILOILO

The National Irrigation Administration (NIA) received a funding of P15 million from the National Housing Authority (NHA) for the housing project of the affected Panay Bukidnon Indigenous Peoples (IP) Community of the Jalaur River Multipurpose Project Stage II (JRMP-II) in Calinog, Iloilo.

The said funding is part of the P20-million commitment of the housing agency under the Memorandum Agreement (MOA) signed by both parties for the JRMP-II IP Housing Project on August 3, 2020. The to be displaced 35 IP families during the filling-up of the JRMP-II High Dam will be the recipients and will be resettled in Sitio Agburi, Barangay Cahigon, Calinog.

The JRMP-II Project Management Office (PMO), headed by Acting Project Manager Jonel B. Borres, provided the location of the resettlement site that underwent technical assessments for hazards and other relevant risks. The PMO is undertaking site-development activities after it was found out that the location is conducive for residential housing, such as provisions for community facilities, water system, and access roads to and from the resettlement site.

The P20-million funding from NHA will cover the construction of the 35 housing units with an approved floor area of 35 square meters in a 150-square meter

lot and other entailing works, such as layout and excavation, concrete, masonry, roof and roof framing, carpentry, plumbing, doors and windows, tiles, painting, electrical with solar panels, and construction of project marker. The housing project will still exhibit the culture and tradition of the affected IP community.

The resettlement site is a commitment of NIA under the MOA by and between the Agency, the IP community, and the National Commission on Indigenous Peoples during the free and prior informed consent process of the project.

With the goal of providing vital contribution to irrigation development in the country, the National Irrigation Administration (NIA) turned over two irrigation projects to two Irrigators Associations (IAs) in the Province of Rizal on June 24, 2021 at Barangay Calawis Covered Court, Antipolo City, Rizal. These projects are Calawis Small Irrigation System (Calawis SIS) located in Antipolo City and Palay-Palay Pump Communal Irrigation System (Palay-Palay PCIS) in the Municipality of Jala-Jala with an aggregate cost of P22.007 million.

Calawis SIS, whose water source comes from Calawis Creek, includes the construction of check structure and installation of pipeline with four water tanks and accessories. With a total cost of P15.007 million, the project is expected to provide timely and reliable irrigation water supply to 43 hectares of agricultural land in Antipolo City, benefitting 20 farmers and their families. Administrator Visaya led the turnover ceremony of the project to Calawis IA, represented by IA President Ronnie R. Idala.

On the other hand, Palay-Palay PCIS, whose water source come from Laguna Lake, includes the fabrication and installation of solar panel board, solar controller/inverter, and solar panel frame. With a total cost of P7 million, the project is expected to provide a year-round irrigation water supply to 142 hectares of agricultural land in the Municipality of Jala-Jala, benefitting 110

farmers and their families. The project was turned over by NIA Administrator Visaya to Palay-Palay IA, represented by IA President Eliseo SM. Inguito, Jr.

As part of its innovation and modernization platform, NIA ventures into solar-powered pump irrigation projects like Palay-Palay PCIS to replace diesel-powered pumps and generators which emit considerable quantities of carbon dioxide and greenhouse gases. In addition, diesel-powered projects are high in operations and maintenance costs. Hence, the Agency started developing solar-powered pump irrigation projects due to its environmental friendliness, durability, and long-term cost-effectiveness.

NIA Deputy Administrator for Administrative and Finance Sector Romeo G. Gan, NIA CALABARZON Regional Manager Romeo M. Lopez, Laguna-Rizal IMO Acting Manager Gerardo R. Perez, represented by Senior Engineer Leilani Dela Cruz, Antipolo City Mayor Andrea B. Ynares, represented by City Councilor Irvin Paulo C. Tapales, Barangay Captain of Calawis, Antipolo City Allan A. Abonio, other NIA Central Office and Regional Officials and employees, some uniformed personnel, and IA members attended the turnover ceremonies.

NIA is now looking forward to the development of more solar and floating solar power projects to cover more agricultural areas nationwide.

NIA PRESSES ON WITH REFLEETING, GETS NEW LIGHT AND TRANSPORT EQUIPMENT



The acquisition of light/transport equipment is in line with the Four-Point Agenda of Administrator Ricardo R. Visaya, particularly in instituting measures to improve the delivery of services, such as but not limited to, modernization of equipment for operations and project implementation.

Thus, the National Irrigation Administration (NIA) acquired 95 units of light and transport equipment worth P155.315 million for use in the monitoring and evaluation of the status of on-going construction and Operations and Maintenance (O&M) activities.

These light and transport equipment were turned over in a simple ceremony on June 21, 2021 at the NIA Grounds. The winning bidder, CT Citimotors – Mitsubishi Motors Philippines Corporation, represented by Mr. Lorenzo Cucio (Mitsubishi Motors) and Citimotors Assistant Vice President Rodrigo Almedral led the symbolic turnover of the key to NIA Top Management Officials, witnessed by Central Office Department Managers and employees.

The purchase of light/transport and heavy equipment is part of the three-year re-fleeting program of the Agency from CY 2017. For CY 2017, NIA purchased 34 units of light/transport vehicles and 17 units of heavy equipment. For CY 2018, NIA acquired 91 units of light/transport vehicles and 18 units of heavy equipment. Meanwhile, five units of heavy equipment and 91 units of light/transport vehicles were set for procurement in 2019

As of December 31, 2020, NIA maintained in operating condition 3,201 units of heavy, light/transport, other support, and special equipment in support to the

operations and maintenance of irrigation systems nationwide. On the other hand, 622 units of equipment are non-operable or needing repair while 1,382 units of equipment are recommended for disposal. Thus, the three-year re-fleeting program is expected to make NIA operations more efficient and reliable.

Handover Ceremony of Shotguns for Added Security

Preceding the handover ceremony of equipment was the handover of 319 units of shotgun and ammunition from Trust Trade, Inc., represented by Ms. Marinyl S. Belino, to NIA Administrator Visaya. The Administrator then turned over the shotguns to the Civil Security Affairs Office headed by Engr. Eusebio S. Villamanto.

NIA CONDUCTS SIMULTANIEOUS TREE PLANTING ACTIVITY NATIONWIDE



The National Irrigation Administration (NIA) held a simultaneous Tree Planting Activity on June 25, 2021 at NIA Field Offices nationwide as part of the Agency's National Greening Program and 58th Founding Anniversary Celebration. The activity was conducted with the theme, "Tubig-Kanlungan ay Pangalagaan, Patuloy na Daloy ng NIA sa Gitna ng Pandemya".

Due to COVID-19 travel restrictions, the Environmental Watershed Management Section (EWMS) under the roject Planning Division, Administrative Department (PPD-ED), which is currently in charge of the NGP, has limited the number of staff who will participate in the activity. Before leaving, all participants guaranteed that they had taken an antigen test. A total of 32 personnel from NIA Central Office were divided to participate in the exercise. One team attended UPRIIS while the other attended Region IV-A.

A total of 75 officials and employees from the NIA-UPRIIS Head Office and Division III, led by Department Manager Rosalinda B. Bote, along with PAIS-Central Office Acting Department Manager Eden Victoria C. Selva and 15 other NIA Central Office employees, planted 500 rambutan and duhat seedlings at the 6,000-square-meter watershed area of the Upper Tabuating Small Reservoir Irrigation project of NIA.

A total of 1,500 seedlings of bamboo, bayog, teak, coffee, palosapis, yakal, and dungon were also planted

by 100 officials and employees of UPRIIS Dam and Reservoir Division, Divisions II, IV, and V, and Interim Division VI along Decoliat River, Sitio Marikit East, Barangay Lublub, Castaeda, Nueva Ecija. UPRIIS Division I employees are also slated to plant trees in the Macanae Watershed area, which is located in the Municipality of Lupao, Nueva Ecija.

The other team from NIA Central office joined the NIA CALABARZON Regional Office's tree planting exercise, headed by Regional Manager Romeo M. Lopez, in Barangay Calumpang, Liliw, Laguna, which is part of the Sta. Cruz River Irrigation System (Sta. Cruz RIS). Seventy people planted 300 fruit-bearing trees, including duhat, kasoy, guyabano, and rambutan.

A short program was held before the actual tree planting activity to instruct participants on the proper planting method to avoid the mortality of planted seedlings.

Indeed, NIA has lived up to its promise of being a caring institution for both farmers and the environment. NIA Top Management officials, led by Administrator Ricardo R. Visaya, see the action as a platform for revitalizing and protecting the country's watershed areas, caring for Mother Earth, and planting new hope for future generations. It is also a means for us to reconnect with Mother Earth after months of restricted movement and travel.

Nag-apply ako rito sa Cash and got hired as a Senior Collection Officer. Ako 'yong tumatanggap ng mga collection natin, ako 'yong nangongolekta. May ka-alternate ako, si Donna, kasi in case nga na wala ako ay siya ang gumagawa. Pero kung parehas kaming nandito, ako talaga ang nagreresibo. 
