# 5,412 FARMERS TO BENEFIT FROM 18 IRRIGATION PROJECTS WORTH P1.775 BILLION

A total of 5,412 farmers tilling 6,238.96 hectares of agricultural land nationwide will benefit from the 18 irrigation systems recently inaugurated and turned over by the National Irrigation Administration (NIA). These projects with an aggregate cost of P1,775,256,282.00 include 1) P150.44-million San Fabian River Irrigation System (San Fabian RIS) in San Fabian, Pangasinan on July 9, 2021, 2) P1.391-billion Upper Malitubog Service Area (UMSA) in Pikit, North Cotabato on July 8, 2021, 3) P18.5-million Laya West Communal Irrigation System (Laya West CIS) Phase II in Barangay Laya West, Tabuk City, Kalinga on July 7, 2021, and 4) mass turnover of 15 irrigation projects in Region XII amounting to P215,316,282.00 on July 5-8, 2021. The inauguration of the newly rehabilitated San Fabian RIS under the National Irrigation Sector

Rehabilitation and Improvement Project (NISRIP) was led by NIA Administrator Ricardo R. Visaya in Barangay Binday, San Fabian, Pangasinan, together with NIA Region I Manager Angelito S. Miguel, NISRIP Project Manager Silvino C. Navarro, San Fabian Farmers IA President Bernie Dispo, and Ms. Ayumu Ohshima of Japan International Cooperation Agency (JICA) which partly funded the project. With water source from Bued River, the project has a Firmed-Up Service Area (FUSA) of 2,116 hectares in the municipalities of San Fabian, San Jacinto, and Manaoag, benefitting 1,566 farmers and their families.

The turnover ceremony of completed irrigation facilities for UMSA was led by Deputy Administrator for Engineering and Operations Sector C'zar M. Sulaik at Pikit Gymnasium, Pikit, North Cotabato, together with NIA Region XII Manager Diosdado A. Rosales, MMIP-II Acting Project Manager Saleh P. Kabunto, local government officials, and IAs. With water source from MMIP-II Diversion Dam, UMSA is expected to provide timely and reliable irrigation water supply to 2,464.96 hectares of agricultural land in the municipalities of Aleosan and Pikit, benefitting 2,004 farmers comprising 11 organized IAs.

LITATION AND IMPROVEMENT

The turnover ceremony of Laya West CIS to Jose Anniban Farmers IA, headed by IA President Reynaldo Wansi, was presided by NIA-CAR Regional Manager Benito T. Espique, Jr. Funded by the Comprehensive Agrarian Reform Program (CARP) of the Department of Agrarian Reform (DAR), the project covers 133 hectares of rice farm in the Barangay Laya West, benefitting 76 farmers and their families.

The Mass Turnover of 15 irrigation projects in Region XII amounting to P215,316,282.00 on July 5-8, 2021 presided by NIA Deputy Administrator for Engineering and Operations Sector C'zar M. Sulaik

Meanwhile, the four-day mass turnover ceremony of irrigation projects in Region XII was presided by Deputy Administrator Sulaik. On July 5, 2021, Seven Lakes SIP, Labanang SIP, Elvas SIP, and Ala RIS Extension all in the Province of South Cotabato with an aggregate cost of P56,656,687.00 were formally turned over by NIA to four respective IAs. These projects will provide timely and reliable irrigation water supply to 126 hectares of agricultural land in the Province of South Cotabato, benefiiting 67 farmers and their families. During the second day, Badtasan CIS and Domolok-Tokawal CIS were turned over by the Agency to Badtasan IA and Domolok-Tokawal IA. The two projects have a total cost of P51,760,340.00 and will irrigate 944 hectares of farmland in the Province of Sarangani, benefitting 469 farmers and their families.

On July 7, 2021, Buklod SIP, Nati CIS, Kiadsam CIS, Sarip Pedregosa CIS, and SMN CIS were officially turned over by NIA to respective IAs. With an aggregate cost of P76,899,255.00, the five projects will benefit 297 farmers with a total service area of 232 hectares in the Province of Sultan Kudarat. During the fourth day, Malu-ao CIS, Manuangan CIS, Tigbawan CIS, and Midbal CIS were turned over by the Agency to respective IAs. The four projects have a total cost of P30,000,000.00 and will irrigate 223 hectares of farmland in the Province of Cotabato with 933 farmer-beneficiaries. Capping the mass turover ceremonies of irrigation projects was the signing of turnover documents with NIA Deputy Administrator Sulaik, local government officials, and IA officers.

On June 24, 2021, NIA inaugurated the P14.223-million Calawis Small Irrigation System (Calawis SIS) located in Antipolo City, Rizal and P6.657million Palay-Palay Pump Communal Irrigation System (Palay-Palay PCIS) in the Municipality of Jala-Jala, Rizal. These turned over projects with a total cost of P1,796,137,901.31 are included in the targeted 71 projects to be inaugurated until August 2021. Five other projects are scheduled for turnover before the end of July.

NIA Top Management Officials, headed by Administrator Visaya, assured that the Agency remains unstoppable in providing efficient, reliable, and sustainable irrigation service to the Filipino farmers amidst pandemic.



The National Irrigation Administration (NIA) inaugurated the P171.97-million newly rehabilitated Porac-Gumain River Irrigation System (PGRIS) and turned over Irrigators Association (IA) Office with Support Facilities on July 22, 2021 in the Province of Pampanga.

The rehabilitated Porac-Gumain River Irrigation System under the National Irrigation Sector Rehabilitation and Improvement Project (NISRIP) is funded through a grant from Japan International Cooperation Agency (JICA) amounting to P171,973,175.95. The project is expected to provide timely and reliable irrigation service to 3,249.95 hectares of agricultural land in the municipalities of Lubao, Floridablanca, Guagua, and Sta. Rita in Pampanga Province, benefitting 4,045 farmers and their families.

NIA Administrator Ricardo R. Visaya led the inauguration and turnover ceremony. Also present during the event were NIA Deputy Administrator for Administrative and Finance Sector Romeo G. Gan, representatives of JICA headed by Chief Representative AZUKIZAWA Eigo, local government officials headed by representative to the Mayor of the Municipality of Floridablanca, Mr. Tito Mendiola, NISRIP Project Manager Silvino C. Navarro, NIA Region III Manager Josephine B. Salazar, and Pampanga-Bataan Irrigation Management Office (PAMBAT IMO) Manager Isabelito V. Bitangcol.

IA President Romeo P. Pingul expressed his deep gratitude to NIA and JICA for the rehabilitation works of the Porac-Gumain RIS that will greatly help them, the local farmers.

"Mayroon kaming commitment o ipinangako sa NIA na aalagaan namin nang mabuti at mamahalin namin ang lahat ng naibigay ninyo dahil 'yan ay tulong sa aming mga anak, mga kapatid, at mga kababayan sa apat na munisipyo dito sa second district", IA President Pingul said in his message.

Cabinet Secretary Karlo Alexei B. Nograles delivered his message through a pre-recorded video. He acknowledged the significant contribution of Porac-Gumain RIS to the farmers and in the agricultural sector of our country in these challenging times of pandemic.

"These rehabilitation works will truly pave the way for the increase in production of our farmers which in turn will improve their profitability and livelihood. Napakagandang balita ito para sa ating magsasaka lalo na sa pandemya na ating kinahaharap sa kasalukuyan. Sa panahong ito, mahalaga na mapanatili natin ang daloy ng mga irigasyon patungo sa sakahan. Sa patubig, totoong may pagkain", Cabinet Secretary Nograles remarked. In his video message, His Excellency Ambassador KOSHIKAWA Kazuhiko of the Embassy of Japan emphasized the strong relationship of Philippines and Japan through improvements of irrigation systems.

"It is an honor to be in close cooperation with the National Irrigation Administration, the local government units, and most importantly the farmers part of the Irrigators Associations. The continuous success and achievement of National Irrigation Sector Rehabilitation and Improvement Project provide a gleaming testimony of the relationship between Japan and the Philippines. It shows us with diligence in working collectively for the gloss of farm sector, we can achieve our goals in spite of the pandemic", he stated.

Cabinet Secretary Nograles and Administrator Visaya extended their gratitude to the Japanese Government through the Embassy of Japan and JICA, for its continuous assistance to the Philippine Government particularly, in helping the Filipino farmers through NIA, in providing them with rehabilitated irrigation systems.

Furthermore, Administrator Visaya highlighted in his message that NIA,

since the assumption in office of President Rodrigo Duterte, is eager to fast track the construction of all the projects.

"The government, under the leadership of President Rodrigo Duterte, is continuously seeking viable solutions to further increase our farmers' yield and to improve their quality of lives, most especially in this time of the pandemic. So with that, even during the pandemic construction did not stop. In fact, there are more than hundred projects that we have to inaugurate until the end of this year worth about P27-billion. Ito ang nagpapatunay na even during the pandemic, the National Irrigation Administration did not stop in the construction of our irrigation systems", Administrator Visaya said.

The rehabilitation works of Porac-Gumain RIS involved replacement of the falling shutter and provision of trash rack at intake in Porac Dam, replacement of sluicegate with rubber seal in Solib Dam, 10.045 kilometers of concrete canal lining, improvement of 20 check gates, and eight IA offices with three support facilities.

QUIPOT IP IRRIGATE 2,800 HECTARES OF AGRI LANDS IN QUEZON PROVINCE Year-round irrigation water and more yield is now possible in the Province of Quezon as the National Irrigation Administration (NIA), headed by Administrator Ricardo R. Visaya, inaugurated and partially turned over the Quipot Irrigation Project on July 21, 2021 in the Municipality of Tiaong, Quezon.

The locally funded project amounting to P1,499,500,000.00 (Phase 1 = P999.5 million, Phase 2 = P450 million) aims to promote self-sufficiency in rice production, improve the average cropping intensity, increase irrigated area and paddy yields during wet and dry seasons in the Municipalities of Tiaong, San Antonio, Candelaria, and Sariaya, all in Quezon Province, and San Juan and Rosario, Batangas.

NIA IV-A Regional Manager, Romeo M. Lopez emphasized the possible benefits and outcome of the project for the whole province.

"Ang proyektong patubig na ito ay nagpapakita ng potensyal ng Quezon



na maging aktibong kabahagi ng pagsulong ng agrikultura hindi lamang dito sa probinsya kung hindi maging sa buong rehiyon. We are confident that with all your support, commitment and cooperation hindi malayong maabot ng CALABARZON ang food security sa rehiyon", Regional Manager Lopez said.

Its main features are the construction of a diversion works, irrigation facilities and access/service roads. It is a Check Gate Barrage Type Diversion Works with an estimated water discharge of 5.95 cubic meter per second (cms) with a height and crest length of 5.50 meters and 50.30 meters. It is the biggest barrage type dam ever constructed in CALABARZON.

NIA Administrator mentioned in his speech that this project took long years to happen but President Rodrigo Roa Duterte instructed him to fast tract all projects.

"We seek the approval of IATF for us to continue the project dahil hindi puwedeng maantala itong mga ito dahil it is related to food production. There were delays like natural disasters and existing COVID-19 pandemic which started last March, despite that "Tuloy Ang Daloy NIA", he added.

Moreover, NIA Administrator said that the start of devolution will also be the start of a more important task of NIA which is to make the irrigation systems more efficient. The Agency will be concentrating in the management and operation and maintenance of National Irrigation Systems (NISs).

NIA Top Management, Region IV-A and Irrigation Management Office (IMO) heads and staff, Local Government Units (LGUs), and Irrigators Association (IA) Officers and farmer-members attended the ceremony and voiced their titude for the successful project.

# **WASHED-OUT MAIN CANAL EXTENSION RESTORED** IN THE SECOND LARGEST RICE-PRODUCING TOWN IN CAGAYAN PROVINCE

Severely damaged during the extreme flooding in Cagayan Province brought by Typhoon Ulysses in November last year, the East Apayao-Abulug Irrigation System (EAAIS) located in the Municipality of Allacapan, the second largest rice producer in Cagayan province, has been prioritized to be restored by the National Irrigation Administration (NIA).

On July 21, 2021, the Agency conducted the inauguration ceremony of the P28.242-million newly-restored Main Canal Extension of EEAIS presided by NIA Senior Deputy Administrator (SDA) Abraham B. Bagasin.

Restoring the washed out section

With water source comes from Apayao-Abulug River, the restoration of the project will cover additional 80 hectares of agricultural land in the Municipality of Allacapan with 38 farmer-beneficiaries. At present, the project has a total service area of 2,164.275 hectares, benefitting 1,797 farmers and their families.

SDA Bagasin lauded the collaborative efforts of the officials manning EEAIS for fast tracking the rehabilitation of the said irrigation canal taking into consideration the need to provide water supply to the agricultural lands of over a thousand of farmers who are dependent on the irrigation canal's service.

NIA Region II Manager Raymundo B. Apil, Allacapan Municipal Mayor Harry D. Florida, other officials and employees from NIA Central Office, NIA Region II, and Cagayan-Batanes IMO, IA officials, and some officers and farmer-members of Allacapan Centro East Dagupan Irrigators Association attended the ceremony. The East Apayao-Abulug Irrigation System serves the towns of Abulug, Allacapan, Ballesteros, Aparri and Pamplona in Cagayan province and likewise in the towns of Flora and Sta. Marcela of Apayao Province.

# BULADO<br/>SUPSUPSUPSUPTO IRRIGATE AGRI LANDS IN<br/>TAGAYTAY CITY

On July 27, 2021, the National Irrigation Administration (NIA) held the Turnover Ceremony of the P6million Bulalo Small Irrigation Project (Bulalo SIP) in Barangay Iruhin East, Tagaytay City, Cavite. The project was handed over to the Bulalo Damayan Irrigators Association, Inc., led by IA President Fernando Burazon, for operation and maintenance. The ceremony was presided by Senior Deputy Administrator Abraham B. Bagasin.

Bulalo SIP includes the construction of solar pump, solar pump facilities and accessories, two concrete water tanks, trash track, pipelines, and check structures. The project is expected to provide timely and reliable irrigation water supply to 15 hectares of agricultural land in Tagaytay City, benefitting 34 farmers and their families.

In his message, Senior Deputy Administrator Bagasin emphasized the importance of close inter-agency coordination in the completion of various irrigation projects across the country. He emphasized that these projects are for the benefit of farmers and contribute to agricultural development. "Nagpapasalamat kami sa ating mga LGUs na talagang sumusuporta sa ating mga proyekto. Hindi magiging matagumpay ang mga ganitong proyekto ng pamahalaan kung wala ang suporta ng ating mga kasamahan sa Provincial, District, at Local Governments", said Senior Deputy Administrator Bagasin.

NIA CALABARZON Regional Manager Romeo M. Lopez emphasized the great contribution of agriculture to economic development. He also stated that the Agency is focusing not only on irrigating rice lands, but also on our farmlands that cater to diverse/high value crops.

"Isa ang proyektong ito sa tinatawag nating modernization effort ng ating mga irrigation facilities. Ang solar irrigation project na ito ay malaki ang maitutulong sa ating mga magsasaka para mabawasan ang kanilang gastos sa pagsasaka, sapagkat hindi na sila gagastos pa sa gasolina para mapatakbo nila ang kanilang mga water pump", said Regional Manager Lopez.

Officials from NIA CALABARZON Regional Office, Cavite-Batangas Irrigation Management Office (CBIMO), and Local Government Units (LGUs), IA officers, and farmers attended the ceremony.

Capping the event was the ceremonial turnover of the symbolic keys of five other irrigation projects in the Province of Cavite, namely, 1) Pacheco PCIP to Pacheco Agrarian Reform Cooperative, headed by IA President Filomino Hernandez, 2) Balayungan PIP to Malainen Luna Eco-Farm IA, represented by IA President Darwin Saloria, 3) Urdaneta PIP to Urdaneta Magallanes IA, headed by IA President Pablito Rogador, 4) Medina PIP to Magallanes Samahang Magsasaka ng Kay-Apas at Medina Agriculture Cooperative, represented by IA President Mariano Maligaya, and 5) Ramirez PIP to Ramirez IA, headed by IA President Rey Villaruel.

NIA Top Management Officials, headed by Administrator Ricardo R. Visaya, assure that the Agency will continue to develop solar power projects due to its environmentalfriendliness, durability, resistance to corrosion, and long-term cost effectiveness, thus uplifting the lives of greater Filipino farmers.

# SAN ISIDRO AND PENARANDA SOLAR-POWERED SOLAR-POWERED PUMPS: IMPROVEMENT OF IRRIGATION FACILITIES IN NUEVA ECIJA

Independent power system for irrigation will now benefit 273 farmers in the Province of Nueva Ecija as the National Irrigation Administration (NIA), headed by Administrator Ricardo R. Visaya, inaugurated the newly completed Solar-Powered Pumps located at Barangay Pulo, San Isidro and Barangay San Jose, Peñaranda, Nueva Ecija on July 27, 2021.

In her speech, NIA UPRIIS Department Manager Rosalinda B. Bote stated that "Ang pagtatayo ng solar-powered pumps ay isa sa mga bago at daynamikong proyekto na pinagtutuunan ng pansin ng NIA, sapagkat malaki ang naitutulong nito sa mga magsasaka hindi lamang para mabawasan ang konsumo sa paggamit ng tradisyunal na diesel powered pump kung hindi pati na rin sa pagpoprotekta sa ating kalikasan."

San Isidro Solar-Powered Pump Irrigation Project is located at Barangay Pulo, San Isidro, Nueva Ecija with a service area of 323.2762 hectares. The total cost of this project is P17,780,519.47 with 159 farmerbeneficiaries covering Barangays Pulo and Mangga. While the Peñaranda Solar-Powered Irrigation Project is located at Barangay San Josef, Peñaranda, Nueva Ecija with a service area of 228.878 hectares costing Php 20,461.285.99. This project covers Barangays Poblacion I, Poblacion II, Santo Tomas in Peñaranda and Pambuan in Gapan City with a total of 114 farmer-beneficiaries. The system capacity of both solar panels is 90,390 watts.

In his message, NIA Administrator said that even solar-powered pump projects are more expensive, more or less it will reach 25 years in providing service and also maintenance free.

"Kung 'yong pump ay one hundred thousand lang whereas the solar is about millions of pesos, in the long run makakatipid ang ating mga magsasaka, mas marami ang mapoproduce nila at gaganda ang buhay nila", he added.

IA President of Peñaranda and Representative of San Isidro LGU expressed their gratitude to the whole Agency. They emphasized the immense advantage and effect of having solar-powered pump irrigation projects as it will reduce the production cost in their barangays. Further, the Administrator voiced his appreciation for the support of all people behind the success of the projects in the province of Nueva Ecija.

"Sa atin pong mga magsasaka, patuloy po tayong magtulungan, itong mga solar panels sana ay alagaan natin", NIA Administrator said.

The ceremony includes Ribbon Cutting, Unveiling of Marker, Blessing, and Ceremonial Test Run of Solar-Powered Pumps attended by NIA Top Management, Upper Pampanga River Integrated Irrigation Systems (UPRIIS) heads and staff, Local Government Unit (LGU) leaders and representatives, and Irrigators Association (IA) Officers and farmermembers.

The Agency is hoping that success will continue to ignite and inspire each and everyone to be of service to Filipino farmers.

# **2,532 FARMERS** TO BENEFIT FROM P46.92-MILLION WORTH OF IRRIGATION PROJECTS IN CAMARINES SUR, BICOL

A total of 2,532 farmers tilling 1,963.12 hectares of agricultural land in Camarines Sur, Bicol Region will benefit from three inaugurated and turned over irrigation systems by the National Irrigation Administration (NIA) on July 29, 2021. These projects with an aggregate cost of P46,924,543.18 include 1) P26.160-million Pump House and Farm Pond at Tigman-Hinagyanan-Inarihan River Irrigation System (THIRIS) in Calabanga, Camarines Sur, 2) P14.077-million Punta Diamante Pump Irrigation System in Canaman, Camarines Sur, and 3) P6.686-million rehabilitated Taisan CIS Dam (Sibagat Small Reservoir Irrigation Project) in Minalabac, Camarines Sur.

The construction of Check Gate of Punta Diamante Pump Irrigation System is expected to provide timely and reliable irrigation service to 250 hectares of agricultural land in the barangays of Haring, San Agustin, San Vicente, and portion of Dinaga, Canaman, Camarines Sur, benefitting 122 farmers and their families. Likewise, the construction of Pump House, Farm Pond, Canal Structures, and Canalization Works of Tigman-Hinagyanan-Inarihan River Irrigation System (THIRIS) will provide irrigation service to 1,363.12-hectares in Calabanga, Camarines Sur that will benefit 2,245 Bicolano farmers. Also, the newly rehabilitated Taisan Dam is set to irrigate Punta Diamante Pump Irrigation System in Canaman, Camarines Sur

350-hectares of farmlands in the Barangays San Jose and Magadap in Minalabac, Camarines Sur with 165 farmer-beneficiaries.

The inauguration of the irrigation projects under NIA Region V was led by NIA Administrator Ricardo R. Visaya. NIA Deputy Administrator for Administrative and Finance Sector Romeo G. Gan, Camarines Sur 2<sup>nd</sup> **District Representative Luis Raymund** Villafuerte, Camarines Sur 3<sup>rd</sup> District Representative Gabriel Bordado, Municipality of Minalabac Mayor Christopher Lizardo, NIA Region V Manager Freddie M. Toquero, **Camarines Sur Irrigation Management** Office (CSIMO) Acting Manager Alvin L. Macasinag, Irrigators Associations (IA) officers, and local farmers attended the event.

Camarines Sur 2<sup>nd</sup> District Representative Luis Raymund Villafuerte expressed his gratitude to NIA for the irrigation projects in the province that significantly impacts Bicolano farmers. He also called for support for the Sustainable Bicol River Irrigation System.

"Sana po ay patuloy pa rin ang pagmamahal at pagtulong ninyo sa aming probinsiya. Ang Camarines Sur ay Top 5 in the country as rice producing province. Kahit na kaunti pa lang ang irrigation systems namin dahil karamihan ay rainfed ay Top 5 kami. Kaya ako nakikiusap sa NIA na sana ay magtulungan po tayong lahat starting from General Visaya down to the lowest level employee ng NIA para matuloy po 'yong tinutulak namin na Sustainable Bicol River Irrigation System. More than 2,000 hectares po ang matutulungan na farmers ng mga pananim na bigas. Kapag ito po ay natapos, baka mag-Top 3 po kami sa buong Pilipinas", he said in his message.

Further, Administrator Visaya stressed in his message that NIA continues to develop and construct irrigation systems nationwide amidst the pandemic.

"For the last two months lang, including these in Camarines Sur, we inaugurated 153 projects worth more than P11 billion. Tatlo ngayon ang na-inaugurate namin dito sa Camarines Sur. And for next month, sa August, we will be inaugurating about 35 projects worth P2.7 billion. So, isa lang po ang ibig sabihin nito. Walang pandemya sa NIA. Tuloy ang daloy NIA", Administrator Visaya said.

# **NIA AND SNAP-MI** SIGN P19.986-MILLION SETTLEMENT AND RELEASE AGREEMENT



The National Irrigation Administration (NIA), represented by Administrator Ricardo R. Visaya, and SN Aboitiz Power-Magat, Inc. (SNAP-MI), represented by President and Chief Executive Officer (CEO) Joseph S. Yu, signed the Settlement and Release Agreement amounting to P19,986,308.78 on August 3, 2021 at the Administrator's Conference Room, 2nd Floor, Building B. The amount serves as a payment of SNAP-MI to NIA for the utilization of excess irrigation water for power generation.

SNAP-MI acquired the 360-megawatt Magat Hydroelectric Power Plant (MHEPP) from the National Power Corporation (NPC) in a competitive bidding conducted by Power Sector Assets and Liabilities Management Corporation (PSALM). As part of the acquisition, NIA entered into an Operations and Maintenance (O&M) Agreement with SNAP-MI on December 13, 2006 for the non-power components of the Magat Dam owned and operated by NIA primarily for irrigation purposes and secondarily for power generation.

In the course of the implementation of the O&M Agreement, some issues have arisen in relation to the interpretation and application of certain provisions thereof. On June 18, 2008, in order to resolve the then pending issue on the pricing of water for the volume used in excess of the Irrigation Diversion Requirement (IDR) during times that the actual reservoir elevation is above the Rule Curve Elevation, the MHEPP Oversight Committee (OC) issued Resolution No. 1, series of 2008 providing the unit of water price to be adopted in computing the water service fee for MHEPP.

For the period of November 2010 to February 2011, NIA is claiming from SNAP-MI the amount of P9,267,898.79 as income opportunity loss due to non-use by SNAP-MI of the full IDR for generation of electricity while the latter is operating for ancillary services. SNAP-MI has disputed on the basis that the service fees shall be computed based on the volume of water used for power generation as provided under the Section 3.1 of the O&M Agreement (Issue No. 1).

For the period of May 2009 to September 2009, NIA is claiming from SNAP-MI the amount of P10,718,409.99 for water consumed above the IDR during spilling conditions following the rate of P0.062 as prescribed under the OC Resolution, but which SNAP-MI has disputed on the basis that the regular rate of P0.031 shall be applied in case of surplus flows that would otherwise be spilled if not used for power generation pursuant to the exception in Section 3.6 of the O&M Agreement (Issue No. 2). The two parties have

different positions on the service fee adjustment provided in Section 3.1.1 of the O&M Agreement, particularly on the frequency, rate, increase/ decrease, and conditions applicable thereto (Issue No. 3).

In consideration of the mutual covenants and agreements established, the Parties agreed that SNAP-MI shall pay a sum of P19,986,308.78 in full and final settlements of Issue Nos. 1 and 2, receipt of which is acknowledged by NIA. The Parties also agreed to modify the O&M Agreement, such that the Service Fee payable by SNAP-MI to NIA shall be computed based on the allocated IDR, whether or not such IDR was utilized by SNAP-MI for the generation of electricity. The Parties also agreed to exert commercially reasonable efforts to reach a mutually beneficial agreement to resolve Issue No. 3 and the prospective application of provisions relevant to Issue No. 2 in an expeditious manner.

All discussions and negotiations with a view to establish an agreement on the foregoing issues became possible and successful through the persistent efforts of NIA Investment Committee on Renewable Energy and Development (NIA-ICRED) through Atty. Mary Annabelle F. Cruz-Domingo. NIA Deputy Administrator for Administrative and Finance Sector Romeo G. Gan, NIA Financial Management Department Manager Editha D. Morales, and some executives of SNAP-MI witnessed the Settlement and Release Agreement.

NIA Top Management Officials, headed by Administrator Visaya, assure that the management continues to explore every option for maximizing the use of its dams and reservoirs nationwide with the goal of increasing the NIA's income that may add up to the operating expenses of the Agency in serving our farmerirrigators. Hence, it has only proven that NIA is more than just irrigation.

# IRRIGATION PROJECTS THREATEND BY SAND AND GRAVEL SITES

The National Irrigation Administration (NIA) infrastructure projects are being threatened by sand and gravel quarry sites. These operate too close to irrigation facilities and structures leading to the adverse effects of excessive quarrying activities, such as exposed foundation of said structures, scoured riverbanks, and degraded river beds.

In Region XI, the Padada River Irrigation System located in Hagonoy, Davao Del Sur is experiencing the effect of quarrying activities adjacent to it. The Diversion Dam of Padada RIS suffers severe damages and exposed sheet piles threatening the foundation of the dam due to severe erosion apparently caused by the quarrying operations downstream. Similarly, the relocated Diversion Dam of Sta. Cruz River Irrigation System situated in Liliw, Laguna under NIA Region IV-A is being threatened again by severe erosion due to quarrying operations downstream. This after the original dam about 800 meters downstream was totally damaged in 2006. These are not isolated cases but rather are a nationwide occurrence. Based on the initial inventory by NIA, there are 116 irrigation systems/projects affected by quarrying activities nationwide.

Quarry operators excavating more than the prescribed one-meter extraction-depth limit, excessive quarrying, including those of river boulders which limit speed of river flow, leading to the diversion of the river course and a steeper river slope resulting in rapid erosion of riverbanks, and the coverage of the quarrying area not effectively marked and delineated using high and conspicuous markers all poses negative effects in irrigation projects nationwide.

With Sibalom River Irrigation System in the Province of Iloilo, Regional Project Monitoring Committee (Region VI) chaired by the National Economic and Development Authority reported on July 9, 2021 that *"the diversion dam is in danger of being severely damage which may be attributed to intensive and improper quarrying within one kilometer downstream, since its end seal and concrete blocks are getting eroded due to continued lowering of the riverbed by around one meter with spillway already hanging which may soon crack and disintegrate".* 

NIA technical survey recommended that the quarry area should be 2.8 kilometers away from the downstream of the diversion dam to allow for the river basin to return to its original elevation and protect the existing irrigation structures. The Agency is calling for the support of the Department of Interior and Local Government (DILG) and the Department of Environment and Natural Resources (DENR) in the strict enforcement and support of the Regional Project Monitoring and Evaluation System (RPMES) for the safeguard and protection of public infrastructure, as well as the preservation of the integrity of the river system supporting irrigation projects, and the review of Section 79. (a) of DAO No. 2020-21 or Implementing Rules and Regulations of Republic Act No. 7942 "Philippine Mining Act of 1995" for further studies for the appropriate delineation of the radius of prohibited quarry areas adjacent to public infrastructure as set forth in Section 79. (a) of DAO No. 2020-21.

This continuous collection of boulders and aggregates in the downstream portion of NIA's structures are causing the rapid erosion of the riverbed which results in the weakening of protecting walls and similar structures. Damage of this kind will eventually lead to the collapse of the entire structure.

NIA Top Management Officials, headed by Administrator Ricardo R. Visaya, assures that the Agency is doing its best to reduce every risk of losing irrigation water supply to our farmer stakeholders and the damage to public property that will entail immense costs for repair and rehabilitation.

Abraham B. Bagasin, fondly called "Abe" by his family and friends, was born in Sanchez-Mira, Cagayan on April 30, 1959. One of the children of Mr. Ireneo and Mrs. Bandelroa Bagasin, he studied at Nagrangtayan Elementary School, Namuac Academy and later at the Philippine Military Academy. General Bagasin is married to Nelia C. Bagasin and is blessed with three children: Karla, Kristina, and Abraham.

General Bagasin is a proud graduate of PMA "Matikas" Class of 1983. He began his military career as a Platoon Leader/Company Commander in the Cagayan, Kalinga, and Apayao. He rose through the ranks and became the Deputy Commander of Northern Luzon Command. His assignments to various command and staff positions honed his potential as a military leader.

Honored by President Duterte's trust and confidence, General Bagasin took the Oath of Office in Malacañang as Senior Deputy Administrator (SDA) of the National Irrigation Administration (NIA) on May 8, 2017 after retiring as an AFP official. Despite the fact that the nature of his work as an SDA is vastly different from his prior duties, he believes that agriculture is one of the most crucial pillars of the country's rising economy. He vowed to work hard to make NIA a wellknown model agency.

Indeed, General Bagasin fulfilled his pledge to co-lead the Agency in providing better and more stable irrigation services to our farmers, as well as reaffirmed his commitment to seeing Administrator Visaya's Four-Point Agenda realized. General Bagasin is a hands-on leader. He made a point of visiting all of the regional offices to check on the status of irrigation projects and systems. He assured to attend Mass Signings of Irrigation Management Transfer (IMT) Contracts. Most importantly, he focused on areas that had been neglected for a long time. As a result of these, he appreciates more and gained a better understanding of the NIA's mission, not only for our

farmers, but also for the Agency's role in agriculture. Together with Administrator Visaya, the NIA established itself as a model agency that provides services free of corruption.

Aside from being the Senior Deputy Administrator, he also led different Committees of the Agency:

a) CHAIRPERSON of the Change Management Team

The Change Management Team (CMT) was created to oversee and review the NIA Reorganization Process and to supervise the selection of Third-Party consultancy services for reorganization pursuant to GCG MC No. 2-15-04. General Bagasin steered the selection of the Third-Party which is CPRM Consultants.

b) **CHAIRPERSON** of Bids and Awards Committee-A (BAC-A). General Bagasin led the BAC-A Committee in accordance with MC No. 66 series of 2021.Big projects such as the JRMP -II, Bulo Earthfill Dam, Chico River Pump Irrigation Projects, Dumuloc Earthfill Dam, Bayuyan Earthfill Dam, Ibingan Earthfill Dam, Malinao Dam Improvement Project, and many others were started under their management.

c) CHAIRPERSON of the Steering Committee of Investment Committee for Irrigation and Renewable Energy Development (ICIRED) As the Chairperson of the ICIRED Steering Committee, their main responsibilities included making final decisions on project proposals endorsed by the Technical Working Group (TWG) for clearance, prioritization, and approval of the Administrator, as well as reviewing and approving for adoption improvement and updates on the guidelines, criteria, and procedures as recommended by the TWG. Under his supervision, 25 MOUs have been approved by the Committee and signed by the Administrator.

### d) **CHAIRMAN** of the Steering

Committee of Information Systems Strategic Plan (ISSP) General Bagasin chaired the Steering Committee of the Information Systems Strategic Plan (ISSP). It presents an agency's overall strategic plan for the development and implementation of Information Systems (IS), the use of Information Communication Technology (ICT), and the corresponding resource requirements. It ensures that ICT efforts are aligned with and prioritized in accordance with the organization's vision, mission, goals, and strategies. The NIA ISSP 2019-2021 was evaluated by DICT. It was passed and adopted during the 955th Regular Board Meeting.

### e) Designated as **QUALITY MANAGEMENT REPRESENTATIVE**

for NIA's pursuit of the International Organization for Standardization (ISO) 9001: 2015 Certification. As **QMR**, General Bagasin ensured that the QMS implementation adhered to ISO key standards and guidelines in collaboration with ISO Teams and the Office of CORPLAN Services.

On September 18, 2018, International Organization for Standardization (ISO) 9001:2015 Certification was conferred to NIA after being assessed by the AJA Registrars. AJA is the third-party ISO-accredited certifying body that audited NIA's Quality Management System (QMS) for public administration of irrigation services on June 27-28, 2018 and bestowed the registration certificate under the management of Administrator Ricardo R. Visaya. The scope of registration focused on the major activities of the four sites of the Agency namely: a) Central Office, b) **Upper Pampanga River Integrated** Irrigation Systems (UPRIIS), c) Regional Office IV-A, and d) Quezon **Irrigation Management Office** (Quezon IMO) in Lucena City, **Quezon Province.** 

NIA is now ISO 9001:2015 certified, following an assessment by Certification International Philippines, Inc. (CIPI) on February 10, 2020. The certification is valid until February 9, 2023. From September 18 to December 17, 2019, CIPI, a thirdparty ISO-accredited certifying body, audited NIA's Quality Management System (QMS) for public administration of irrigation services and bestowed the registration certificate under Administrator Ricardo R Visaya's management. The audit was performed to determine whether the NIA was in compliance with ISO standards. The registration scope was restricted to the Agency's major activities, which included the Central Office, Regional Offices, and Irrigation Management Offices (IMOs).

Prior to his appointment as NIA Senior Deputy Administrator, he was designated as the:

a. MANAGER of Camp Aguinaldo Golf and Country Club b. Appointed as DIRECTOR of the Board of John Hay Management Corporation in Baguio City c. DEPUTY COMMANDER of Northern Luzon Command (NOLCOM) d. REGIMENT COMMANDER of First Scout Ranger

e. COMMANDANT in Officer Candidate School

Romeo Gali Gan or Romie Gan or GenGan or RGG, as he was fondly called, hailed from humble beginnings, and led a colorful life painted with the brightest of white and the bluest of blue. However, he has powered through with strength and grace proving that these bumps in the road might slow you down, but it will never stop you. He was driven by his passion to serve and to serve the country and his countrymen from beginning until the twilight of his life was the greatest honor one could ever have in one's lifetime.

His accomplishments speak volume

and NIANs could attest to the way he had revolutionized and revitalized the Agency. Hence, this tribute will not be about the accomplishments that had been reiterated and recounted throughout, this tribute will be about his life in NIA and how in his own way touched the lives and hearts of the people around him which led to changing perspectives and meeting of the minds. Always for the betterment of the Agency.

### **BUILDING BRIDGES AND NOT WALLS**

MGen Romie Gan is known to be suplado, stubborn, and unrelenting. But despite this seemingly hard exterior, he had the most beautiful heart and would always put the needs of the people first. Another mantra that he echoed when I first entered was, "we should build bridges and not walls." He was the type of leader who wouldn't let his subordinates to make mountains out of molehills. He might not be perfect, but cooperation and trusting that people will see through it despite their differences motivated him to keep on walking as long as it is for the betterment of the people and the Agency.

When he assumed his position as the new Deputy Administrator for Administrative and Finance Sector in September 2017, he walked right in the middle of a divided Agency. He was the type of leader who would listen to your rants and complaints with patience and understanding, like how a father would listen to their children's stories. Those who knew him well know that when the rain is pouring hard, one can always find shelter under his care and will lend a listening ear and offer nuggets of wisdom for those who asked for it. He might have looked aloof and unapproachable, but he was one of the most considerate and sympathetic bosses one could ever have the pleasure of working with.

### **GREAT MINDS RUN PARALLEL**

By building bridges, he had shown his support for his managers and subordinates which was necessary for achieving change and reaching goals. Whenever he arrived at a deadlock

and his ideas aligned with those of his colleagues or he would agree with the suggestions or recommendations offered to him, he would often exclaim that "great minds run parallel." After that, he would give his unwavering support and would stand by your side until the end – or he would expect you to meet, or exceed, if possible, his expectations from the tasks he had just assigned.

Under his leadership, the Finance Department had undergone reforms that ensured effective processes are properly in place to guarantee ease of doing business in the Agency. He had supported his manager, Editha D. Morales, in the necessary changes that must be done to guarantee the mitigation, or even elimination, of recurring problems in the department. Digitization in the processes in the department were started, allocation of budget repair for offices, and implementing systems and processes for transparency and efficiency.

The Administrative Department had time and time again proved their relevance during the time of RGG. Led by the Administrative Department Manager, Atty. Ailyne C. Agtuca-Selda, she had supported the projects that were campaigned for by our DAAF, such as the beautification of NIA, expanding and inclusivity in our training programs, swift response during the pandemic, modernization of NIA equipment and transportation, promoted wellness in the workplace, and digitization of processes in the human resource, procurement and property, and health disclosure check. In return, she also

received unwavering support of RGG in projects that would benefit the Agency and its employees.

Lastly, he was leading parallel to our Administrator. They were complimenting each other, which made them a dynamic duo that led the Agency to achieve greater heights. RGG supported the Administrator in his endeavors and shared the burden. The positive changes that NIA is experiencing right now was brought about by cooperation, collaboration, and support given by the Top Management and between the managers themselves.

### LEGACY LIVES ON

MGen Romeo G Gan (Ret) used to say that he was a kontrabida in NIA, because he was strict and employees should abide by the rules; he was stubborn on certain things and would not budge no matter how much pressure and insistence were put on; and his standards, demands, and expectations were not what some people were used to and the need to exert effort was necessary. He had always thought and felt like he was not loved or even appreciated because of these.

I remember this interview of Karen Davila, which resonated with RGG, where she mentioned that the human psyche wants to be loved, but sometimes doing our job costs something. One cannot please everybody, anyway. Sometimes staying true to your core will make you unpopular but if you will not allow yourself to be lost in the need for love and you follow the path that you were

called for and do it right, anchored on integrity and humility, God will lead you to a path where you will succeed, and you will find your destiny. These words were true. When our beloved RGG joined Our Creator, we saw the overflow of love and gratitude from NIANs. If he could see now how loved he is, he will be surprised. He followed the path given to him and he did not lose himself in his need to be loved. He accepted that he will be unpopular if he did that, but he did not let it stop him and he marched on and stayed true to his principles. At the end of the road, people were waving and cheering for him, it was unfortunate that he did not see nor was he aware of it earlier.

And now the best way to honor and remember him and his contributions to NIA, is to continue his legacy and sustain the changes and keep the momentum going. RGG's enthusiasm has motivated the employees and revived the energy in the Agency. We are now left with the challenge of making him proud wherever he is and making sure that we are doing our best for the betterment of the Agency and its employees. It was unfortunate that not a lot of people knew how wise and generous he was, but maybe in the next lifetime we will be lucky enough to cross paths with him again. Here's an excerpt from his farewell message as a 2ID Commander as my parting words for this tribute, "I hope I have changed your bad habits. To our stakeholders, constituents, and countrymen, I hope I have touched your hearts..."

Thus, he became part of the Philippine Marines, then of the Philippine National Police, serving in various capacities until he became a Police Chief Superintendent. He was assigned as the director of the Police Regional Office of Eastern Visayas dedicated to upholding camaraderie, voluntarism, and excellence. He has faced numerous battles, accomplished several goals, and aided numerous causes. All these he has done with his faith to the Almighty.

It is in NIA that he spent his last years of dedicated service as public servant, particularly as management consultant and head of IAT. For those who are familiar with him, Atty. "Bok, I've been running this endurance course for so long now. I have reached my heartbreak point where I have to let go. I will be intubated now. Whatever the outcome I leave it all to God. Mga mistah, thank you for the journey I had with you since plebehood. Kung sino man ang nasaktan ko sa kayabangan ko, kung sino man 'di napagbigyan, pasensya na, tao lang. Kung saan man akong finish line humantong, see you there sometime to drink our beer."

God has called you home Atty. Asher. Rest in his bosom. Thank you for your life. You'll forever be remembered. You have fought a good fight. You have finished the race. You have kept the faith (2 Timothy 4:7).




