INVITATION TO RID PROCUREMENT OF DAM INFORMATION MANAGEMENT SYSTEM INCLUDING SUPPLY, DELIVERY, INSTALLATION, TESTING AND COMMISSIONING OF EQUIPMENT ITB NO. BS-011-19

- 1. The National Irrigation Administration (NIA), through the Corporate Operating Budget (COB) for 2019 intends to apply the sum of Eight Million Seven Hundred Fourteen Thousand Four Hundred Pesos (Php 8,714,400.00) being the Approved Budget for the Contract (ABC) to payments under the contract for Procurement of Dam Information Management System Including Supply, Delivery, Installation, Testing and Commissioning of Equipment. Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The NIA now invites bids for Procurement of Dam Information Management System Including Supply, Delivery, Installation, Testing and Commissioning of Equipment. 1 Delivery of the Goods is required One Hundred Ten (110) calendar days. Bidders should have completed, within five (5) years from the date of submission and receipt of bids, a contract similar to the Project. For this purpose, similar contracts shall refer to Procurement of Data Management System for Hydrological Data Acquisition and Analysis. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
- 3. Bidding will be conducted through open competitive bidding procedures using a nondiscretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act"

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country

the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.

- 4. Interested bidders may obtain further information from BAC-B Secretariat, c/o Procurement Section, Procurement and Property Division, Ground Floor, NIA Bldg. A, EDSA, Diliman, Quezon City and inspect the Bidding Documents at the address given below during office hours (8:00 AM 5:00 PM).
- 5. A complete set of Bidding Documents may be acquired by interested Bidders on November 1, 2019 to November 25, 2019 from the address below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Ten Thousand Pesos (10.000.00).

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

- 6. The NIA will hold a Pre-Bid Conference on November 11, 2019, 02:00 PM at Classroom A, 3rd Floor DCIEC Building NIA Complex, EDSA Diliman, Quezon City, which shall be open to prospective bidders.
- 7. Bids must be duly received by the BAC Secretariat at the address below on or before *November 25, 2019, 01:30 PM*. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 18.

Bid opening shall be on November 25, 2019, 02:00 PM at Classroom A, 3rd Floor DCIEC Building NIA Complex, EDSA Diliman, Quezon City. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

- 8. The NIA reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
