INVITATION TO BID

**Procurement of Service Provider for the Phase IV of Enhanced Farmland
Geographic Information System (eFGIS Digitization of Parcellary
Maps and Farmland Database Development)
Invitation To Bid No. NIACOIEC-S-3**

1. The National Irrigation Administration (NIA), through the Government of the Philippines (GOP), Corporate Operating Budget (COB), Fund 501-LFPs, Project EFGIS 2022 intends to apply the sum of **Forty-Seven Million Seven Hundred Ninety-Nine Thousand Pesos (PhP47,799,000.00)** being the Approved Budget for the Contract (ABC) to payments under the contract for the Procurement of Service Provider for the Phase IV of Enhanced Farmland Geographic Information System (eFGIS Digitization of Parcellary Maps and Farmland Database Development, Invitation to Bid No. NIACOIEC-S-3. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The National Irrigation Administration *now* invites PhilGEPS registered service provider to apply for eligibility and to bid for the above mention project. The Service Provider shall execute and complete the project within five (5) months upon receipt of Notice to Proceed (NTP). Bidders should have completed a single contract within five (5) years from the date of submission and receipt of bids, a contract similar to the Project with a value of at least fifty percent (50%) or at least two (2) similar contracts and the aggregate contract amounts should be equivalent to at least fifty percent (50%) of ABC having the largest of these similar contracts must be equivalent to at least twenty five percent (25%) of the ABC. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "*pass/fail*" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.

4. Prospective Bidders may obtain further information from the BAC-A Secretariat, 6th Floor, NIA Building A, EDSA, Diliman, Quezon City and inspect the Bidding Documents at the address given below during office hours 7:00 AM to 4:00 PM, Monday to Friday.
5. A complete set of Bidding Documents may be acquired by interested Bidders on March 17, 2022 to April 5, 2022 from the given address and upon submission of Letter of Intent (LOI) and payment to the NIA Cashier a non-refundable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of PhP25,000.00.

The National Irrigation Administration will hold a Pre-Bid Conference on March 24, 2022; 10:00 AM at Classroom A, IEC Building, NIA Complex, EDSA Diliman, Quezon City and may viewed via *Google Meet* through this link: <https://meet.google.com/ycs-ggws-tqy> which shall be open to prospective bidders.
7. Bids must be duly received by the BAC-A Secretariat through manual submission at the office address indicated below on or before April 5, 2022, 12:00 Noon. Late bids shall not be accepted.
8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 14.
9. Bid opening shall be on April 5, 2022; 2:00 PM at Classroom A, 3rd Floor, IEC Building, NIA Complex, EDSA, Diliman, Quezon City and maybe viewed via *Google Meet* through this link: <https://meet.google.com/zhk-hjkg-smg>. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.

The National Irrigation Administration reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
